Resolution # 1

5. DEPUTATIONS/PRESENTATIONS – Dave Darch, County of Renfrew - Public Works and Engineering, Bridges and Culverts Update

This issue will come before County Council after the August county committee meeting. There has been concern about the overview presented regarding the County department restructuring. There has since been some reconsideration of policy –talk about restructuring and some structures going back to municipalities. Report from Department to County later this summer.

- History In 1997 after the "Who does What" exercise policy created direction that county would take control of all bridges within county – all on county and non-county roads – bridges on public rights-of-way – spanning 10' or greater – bridge or culverts
- Director sent out notices let us know which structures meet definition came back with list extensive, no subsidies, feeling that county had a larger tax base to do the work. Very expensive.
- By-laws passed, policy developed 2002? Set out criteria for what constituted a bridge and issues for request for future assumption. If a structure didn't meet the diameter but changes took place, a hydraulic design showed 10' or greater capacity – municipality could come to county to request for consideration for county to take over when structure replacement took place. County would confirm, go to committee and council – when it came time to replace that structure the county would design, construct and assume that structure to county's standard. Financial burden on county.
- Flags going off on infrastructure needs cannot absorb future requests. Last one in 2007 in Horton Township – had to assume a culvert that did not meet criteria but had a huge financial liability.
- Challenge with this structure of infrastructure transfer and policy that allowed the county to take on all costs – design, construction etc. Municipality had to maintain it until it would be replaced. Most do not service high volumes. Not usually a huge problem due to priorities – financial and legal liability of county – would not likely get to them until emergency mode.
- Issue with policy is "future requests".
- Report dated May 5/08. Suggest that the current policy be amended with a couple of recommendations.
- Recommendation 2 Roads that have structures that are seasonally maintained be returned back to the municipality. Grandfather everything save and except for those on seasonally maintained roads.
- Directed to bring back to committee and then to council meet with each council. Explained situation. Some are only seasonally maintained. Not a large number of structures left (3-4) that meet criteria based on preliminary conversations with municipalities. No longer that big of a deal. Thinks that Recommendation 1 will likely be accepted.
- Recommend that grandfather every structure into the program and remove the necessity for the county to assume full responsibility upon request.
- If the structures remain in the policy and under county control they would be severely low in priority.
- Which of ours meet the criteria? Might include Conway Creek. Terry to look into it.
- Mackey Creek Bridge is one of them- we do have the opportunity to work with County; we can apply for grants on their structure if we think repair is a higher priority than the County does, work together to engineer repair and us pay for work? County will post limit when bridge is beginning to wear. If we think it's an issue we can work with them to come to an agreement.
- It is a seasonally maintained road. Recommendation #1 received general approval.

• Assessment report completed in 2007. The bridge on Mackey Creek Road is in good condition. Dave Darch and Wilfred Lamure left the meeting at 14:37.

12. ADDENDUM (NEW BUSINESS)

a. Waste Along Railways

Resolution # 8

Moved by Councillor Foote and seconded by Councillor Reid

WHEREAS railway rights-of-way across the Country are littered with waste flammable products abandoned by the railway operators constituting environmental and safety hazards to the local communities through which they run;

AND WHEREAS in the past our ratepayers have been held financially responsible for the costs of suppressing fires that originated on railway rights-of-way and until legislation is changed, will remain responsible for these costs;

AND WHEREAS in Canada, railways are governed by the *Rules for the Control and Prevention of Fires on Railway Rights-of-Way*, which does not prescribe financial compensation for the costs of fire suppression activities incurred by third parties extinguishing fires that orginated on railway rights-of-way; **AND WHEREAS** there are no regulations under the *Railway Safety Act* (RSA) that prescribe a process of determining or awarding compensation for third parties who incur the costs of fire suppression activities; **AND WHEREAS** the Railway Safety Act Review Advisory Panel has made recommendations to strengthen support for third parties and to make the railway owners and operators more accountable; **AND WHEREAS** the Railway Safety Act Review Advisory panel has stated, "The *Rules for the Control and Prevention of Fires on Railway Rights-of-Way* are neither effective nor enforced, nor do they provide for an adequate process for compensation. Since these rules involve third parties, they should be replaced by regulations."

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria support the position of the Railway Safety Act Review Advisory Panel and call upon Parliament and the Minister of Transportation, Infrastructure & Communities to take action to amend legislation prescribing financial compensation for third parties who incur firefighting costs associated with railway rights-of-way fires and to force railway owners, their operators, employees, and contractors to properly dispose of rail waste in an environmentally aware and safe manner.

AND BE IT FURTHER RESOLVED THAT this resolution be forwarded to AMO for circulation to all Ontario municipalities, to our MP, Cheryl Gallant, to the Minister of the Environment and the Federation of Canadian Municipalities for support.

b. Alternate Work Schedules Policy

Resolution # 9

WHEREAS the Council of the United Townships of Head, Clara & Maria recognizes that the increasing price of fuel erodes financial compensation for employees;

AND WHEREAS a cost free means of aiding employees in meeting the increased costs of fuel and travel could include alternate work schedules ensuring that the same number of hours are worked per week but at flexible times and places;

AND WHEREAS the municipality currently utilizes many of these practises but has not formally adopted a policy;

AND WHEREAS municipal employment policies are essential management tools and help set standards for employee conduct and guidance to management;

AND WHEREAS additional benefits of alternate work schedules would include improved employee morale, improved retention and recruitment, and decreased environmental impact;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby adopt the attached Alternate Work Schedule Policy to be implemented by staff. Carried
