# Solar FIT Proposal - Report #05/12/13/401

## **Subject:**

- 1. Request for support for a Solar Project under the provincial FIT program within Head, Clara & Maria, in Mackey.
- 2. Request for support for a Solar Project under the provincial FIT program within Head, Clara & Maria, in Deux Rivieres.
- 3. Request for consideration of capital participation of up to 35% in one or both Solar FIT projects.
- 4. Request for consideration of capital participation of 10% in one or both Solar FIT projects.
- 5. Request for consideration of support for both projects and lease only in the Deux Rivieres project.

### RECOMMENDATION:

That Council approve the following resolutions providing the project application with "priority points" to improve the chances of approval. It is recommended that Council seriously consider participation in a Public Private Partnership with Azgard Corporation increasing revenues into the future if at nothing else, at least the proposal dated November 20, 2013 with extremely limited financial risk to the municipality as described in options 1 and 2 in the resolution below.

Time is of the essence; a response is requested to be provided at this meeting. Deadline for application for this round of funding is to be completed by December 13, 2013.

### **Resolution #1**

**WHEREAS** the Council of the United Townships of Head, Clara & Maria has considered the viability of entering into a public private partnership with Azgard Corporation for the installation and operation of ground mount solar arrays in each of Deux Rivieres and Mackey;

**AND WHEREAS** Council has reservations about the provincial governments Solar FIT program but does recognize that contracts are still to be awarded under this program and that participation in these projects would provide financial benefit for the residents of Head, Clara & Maria well into the future;

**AND WHEREAS** Council has completed its due diligence and has contacted other municipalities in Ontario where Azgard has completed solar projects and has had no red flags raised;

**THEREFORE BE IT RESOLVED THAT** the Council of the United Townships of Head, Clara & Maria does hereby authorize staff to proceed with working with Azgard Corporation in forming a new company for the sole purpose of applying for and proceeding with the Solar FIT projects, utilizing the services of the municipal lawyer as required, to proceed with participation in:

1.	the proposed project in Deux Rivieres at 15% capital participation with ROI of
	\$340,000 over 20 years, plus an ongoing 15% interest in 500 kW of solar projects, without
	any risk or capital contribution on HCM's part;
2.	the proposed project in Mackey at 15% capital participation over 20 years, plus an
	ongoing 15% interest in 500 kW of solar projects, without any risk or capital contribution on
	HCM's part;
	the proposed project in Deux Rivieres at% capital participation;
	the proposed project in Mackey at% capital participation;
5.	a lease only option for the proposed project in Deux Rivieres;

**BE IT FURTHER RESOLVED THAT** Council does hereby authorize the clerk to complete the appropriate and necessary Zoning Certificates as required under the FIT guidelines.

#### Resolution #2

**WHEREAS** capitalized terms not defined herein have the meanings ascribed to them in the FIT Rules, Version 3.0.

AND WHEREAS <u>Azgard Corporation</u> (the "Applicant") proposes to construct and operate a <u>Solar Project up to 500kW</u> (the "Project") <u>on LT 9 CON A HEAD; HEAD CLARA MARIA (PIN 57040-0006)</u> (the "Lands") in the United Townships of Head, Clara & Maria under the Province's FIT Program;

**AND WHEREAS** the Applicant has requested that Council of the United Townships of Head, Clara & Maria indicate by resolution Council's support for the construction and operation of the Project on the Property;

**AND WHEREAS**, pursuant to the FIT Rules, Version 3.0, Applications whose Projects receive the formal support of Local Municipalities will be awarded Priority Points, which may result in the Applicant being offered a FIT Contract prior to other Persons applying for FIT Contracts;

**THEREFORE BE IT RESOLVED THAT** the Council of the <u>United Townships of Head, Clara & Maria</u> supports the construction and operation of the Project on the Lands.

**AND WHEREAS**, pursuant to the FIT Rules, Version 3.0, Applications whose Projects receive the formal support of Local Municipalities will be awarded Priority Points, which may result in the Applicant being offered a FIT Contract prior to other Persons applying for FIT Contracts;

## **BACKGROUND/EXECUTIVE SUMMARY:**

#### General

Based on the information garnered from various sources, contracts will be awarded for projects in Ontario based on the current agreements approved by the provincial government. It seems that whether or not the projects are located in HCM or elsewhere they will continue to be awarded under the current program.

As we have heard about the provincial government's cancelling existing gas plant projects/contracts, the costs of stopping a program are often significantly higher than simply honouring them. No there is not a guarantee that the new government will do anything however; simply cancelling existing contracts is not a simple thing to do. There are contingencies and backups built in.

As for being able to connect to the grid after the project has been built... that is what the approvals are for. The province approves the project and the connection prior to shovel meeting ground. Funds do not have to be expended or committed by the municipality until the contracts have been approved.

In order to have the "priority points" and to proceed with the desired projects, Azgard is willing to proceed without Council capital as explained in the attached letter dated November 20, 2013. The alternate proposal is a capital contribution of up to 35% for each or any of the proposed projects. This is detailed in the letter dated November 12, 2013. The proposal at 35% would garner a 10.8% Return on Investment.

Even if the County of Peterborough's resolution receives extensive support from the province it is highly unlikely that any changes will be made in the short term; contracts will continue to be awarded.

Resolution #1 is Council's commitment to a public/private partnership with Azgard Corporation in its various forms. Council is to select which option it would like to pursue. Should Council agree to support Azgard's solar projects even without capital participation, Azgard would like to have Council's support as was indicated in their initial contact with the municipality.

Resolutions #2 and #3 provide priority points for those applications, indicating Council's support for the projects but not necessarily participation.

From a taxation and financial perspective the lands would continue to be classed as rural and residential however with a solar array producing up to 500kilowatts the assessed value of the property(s) would increase.

Tax revenues from the Mackey location would continue and at an increased rate. Tax revenues from the Deux Rivieres location would not change as the municipality is the property owner and we do not pay taxes; however annual lease payments of \$4,000 per year could be obtained.

We have been working with Azgard on two projects located within our Township – 1 MG solar project tentatively to be constructed next summer and another smaller solar project in the same area. ## Required by Council – December 5, 2013

From Neale's email dated November 20, 2013, the following is required by the Municipality. By adopting the resolutions included in this report, Council is authorizing staff to proceed with creation of the new company (with assistance from the municipal solicitor). The resolutions required for the "priority points" are included as well.

Report to Council - Solar FIT Program - December 5, 2013Page 5 of 7

- 1. "The documentation and actions required by Council and administration would be as follows:
  - Since a new company (let's call it "AHCM Solar Inc.") would be formed specifically for the projects located in HCM, there may be some documentation to complete but it should be minimal. HCM would hold up to 35% of the common shares of the company, and Azgard Corporation would hold the balance, with a full shareholders agreement to be drafted upon receipt of an OPA contract. If an OPA contract is not awarded, or if the terms of the shareholders agreement cannot be agreed upon, AHCM Solar Inc. would be wound up.
  - A simple lease agreement between HCM and AHCM Solar would be required where HCM would agree to lease the property to AHCM Solar for \$2,000 per year per project subject to the award of an OPA contract. This can be a one page agreement for the purpose of the OPA application (see attached), with a full lease agreement to be drafted upon receipt of an OPA contract. If an OPA contract is not awarded, or if the terms of the lease agreement cannot be agreed upon, the lease agreement would be null and void.
  - A Zoning Certificate would be required for the HCM property similar to the certificate that was provided for the Mackey property.
  - A Municipal Council Support Resolution would be required similar to the resolution for the Mackey property.

## **Options/Discussion:**

Various and numerous including not considering participation at all up to full participation in all projects at 35% capital investment.

# **Financial Considerations/Budget Impact:**

- 1. There is a potential for increased tax revenue with the installation of the solar arrays.
- 2. Potential for annual revenues from a lease agreement of \$4,000 per year \$2,000 per project per year. Over 20 years \$80,000 revenue.
- 3. Potential for annual revenues from capital participation in the project(s) as detailed in Mr. Johannesson's letter dated November 20, 2013 attached with no financial risk to HCM.
- 4. Potential for increased annual revenues from capital participation in the project(s) as detailed in Mr. Johannesson's letter dated
- 5. From Neale's email of November 20, 2013..."Azgard is willing to pay all out-of-pocket costs for the OPA application, including the cost of forming a company for the HCM projects, the cost of preparing the application, and the application fees. Assuming that we receive an OPA contract for one or more projects, these costs will become part of the project costs. If we do not receive an OPA contract, Azgard will not seek any reimbursement from HCM."
