

AUDITOR'S REPORT ON COMPLIANCE WITH AGREEMENT

To the Association of Municipalities of Ontario

We have audited the CORPORATION OF THE UNITED TOWNSHIP OF HEAD, CLARA AND MARIA'S compliance as at December 31, 2010 with the criteria established by the terms and conditions described in Sections 3.1, 5.1, 5.4, 6.2, 6.5 to 6.9, 7.1 a to g, 7.2, 8.1 to 8.3, 9.1, 9.2 and 10.2 of the Municipal Funding Agreement for the Transfer of Federal Gas Tax Revenues Under the New Deal for Cities and Communities dated March 5, 2010 between the Association of Municipalities of Ontario and the CORPORATION OF THE UNITED TOWNSHIP OF HEAD, CLARA AND MARIA. Compliance with the criteria established by the provisions of the agreement is the responsibility of the management of the CORPORATION OF THE UNITED TOWNSHIP OF HEAD, CLARA AND MARIA. Our responsibility is to express an opinion on this compliance based on our audit.

We conducted our audit in accordance with Canadian generally accepted auditing standards. These standards require that we plan and perform an audit to obtain reasonable assurance whether the CORPORATION OF THE UNITED TOWNSHIP OF HEAD, CLARA AND MARIA complied with the criteria established by the provisions of the agreement referred to above. Such an audit includes examining, on a test basis, evidence supporting compliance, evaluating the overall compliance with the agreement, and where applicable, assessing the accounting principles used and significant estimates made by management.

In our opinion, as at December 31, 2010, the CORPORATION OF THE UNITED TOWNSHIP OF HEAD, CLARA AND MARIA is in compliance, in all material respects, with the criteria established by the terms and provisions described in Sections 3.1, 5.1, 5.4, 6.2, 6.5 to 6.9, 7.1 a to g, 7.2, 8.1 to 8.3, 9.1, 9.2 and 10.2 of this agreement.

We appreciate your call of Tuesday, April 19, 2011 concerning the garbage located at the end of Brent Road and other locations throughout Deux Rivieres due to crows and other animals spreading it. Your request to modify the hours of collection will be brought forward to Council for consideration at their next meeting. I will inform you of their decision.

As you might realize, crows and other animals cause the spread of garbage everywhere. It is the responsibility of the property owner to ensure that their garbage is secure and to clean up any mess. If this material belongs to your neighbours, we encourage you to discuss this issue further with them; our driver is not responsible for cleanup.

As you might have noticed at various homes within the Municipality, and elsewhere, people install bins/boxes or old freezers to store their garbage to avoid these problems. Personally, we leave the bags in a garbage can with a lid. If we have placed it outside overnight prior to pickup day, we strap the lid down to keep the racoons out. There are steps that people can take to control the mess and use of the methods above is encouraged.

As promised I will bring your complaint to Council for their consideration.

Dear Honourable Dwight Duncan:

Please be advised that at a meeting of the Council of the Corporation of the County of Renfrew on April 27, 2011 the following resolution was adopted:

WHEREAS Ontario municipalities with post-secondary institutions/hospitals receive transfer payments from the provincial government in lieu of property taxes and;

WHEREAS the payments are transferred to the municipalities based on the number of heads (students) on post-secondary institution campuses and the number of beds in their local hospitals, (also known as the Heads and Beds payment in lieu of taxes) and;

WHEREAS the current amount of \$75 per head/bed has not been increased since 1987 when it was adjusted from \$50 and;

WHEREAS it is our position that the current Heads and Beds rate does not reflect a fair compensation for providing the local resources necessary to support these provincial services and;

WHEREAS this rate, if indexed to inflation, would be approximately \$135 per head/bed;

THEREFORE BE IT RESOLVED THAT the County of Renfrew request that the provincial government of Ontario increase the Heads and Beds levy to at least the current rate of inflation and build in an automatic annual adjustment for inflation for future years; and further,

THAT a copy of this resolution be forwarded to the Honourable Dwight Duncan, Minister of Finance, to John Yakabuski, MPP, Renfrew-Nipissing-Pembroke, the City of Kingston, the City of Pembroke and all local municipalities within the County of Renfrew.

Your government's positive response to this resolution would be appreciated. Thank you.

Re: School Boards' Declaration of Voting Day as a Professional Activity Day

City Council considered the above matter at a meeting held on April 11, 2011 and adopted the following recommendation of the Finance and Administration Committee:

"Whereas Ontario municipalities historically use schools as voting places during municipal elections; and,

Whereas the Municipal Elections Act states that school boards must provide space to be used as voting places free of any charge when requested for use by a municipality; and,

Whereas school boards are requesting municipalities provide security at schools being used on Voting Day to ensure the safety of students throughout the entire school when only a small portion of the school is being used as a voting place; and,

Whereas concerns regarding student safety at the school during voting hours can be eliminated if the students are not in the school on Voting Day;

Therefore Oshawa City Council requests that the Minister of Education amend the Education Act to declare Voting Day for municipal elections in the Province of Ontario as a Professional Activity Day; and,

That this resolution be forwarded to all Ontario municipalities, local MPP's, the Association of Municipalities of Ontario, the Association of Municipal Managers, Clerks and Treasurers of Ontario and all school boards in the City of Oshawa in accordance with Report FA-11-81 dated March 24, 2011."

Council Resolution: Arbitration

Dear Ms. Vanini:

Regional Council, at its meeting of May 5, 2011, approved the following motion:

WHEREAS Niagara Regional Council requested a max 1.4% increase from all departments and Agencies, Boards and Commissions in 2011 budget process and the Police Services Board proposed a 5.48% budget for 2011 and citing the arbitrators decision affecting 92% of their budget;

WHEREAS Regional Council wishes to establish a more co-operative and collaborative approach with the Niagara Regional Police Service Board in preparation for the 2012 budget deliberations;

WHEREAS Regional Council may determine the Regional taxpayer cannot afford to pay a higher tax rate in 2012 than they did in 2011;

WHEREAS Regional Council has passed a motion freezing all non-union and Councillors remuneration packages;

WHEREAS the Provincial Arbitrator has granted a 3% compensation increase package to the Police Officer's Association that affected 2011 but expires at the end of 2011;

WHEREAS the Provincial Government has frozen program funding to Municipalities for compensation increases through Bill 16;

WHEREAS the Police Services Board will begin discussions very soon on issues for negotiations of the next labour agreement with the association, that will affect 2012, 2013 and 2014 budgets; and

WHEREAS Arbitrators have demonstrated a tendency to give far too much weight to clause 122 (5) point 4 which speaks to comparisons with other jurisdictions.

THEREFORE BE IT RESOLVED:

That Regional Council request the Niagara Regional Police Services Board to join Niagara Region in an appeal to the Provincial Government to fix the broken arbitration system and to revisit the Police Act, particularly but not limited to, Section 122 that deals with Arbitrators considerations as outlined in Report CSD 44-2011, February 23, 2011;

That Regional staff advise Regional Council of the best legal wording for the Police Act to achieve this end through research of proposals from AMO and any other source available; and

That this resolution be circulated to the Association of Municipalities of Ontario (AMO) for support.

Subject: CAA (Ontario) and OGRA proposal to have H.S.T. gas tax revenue dedicated to transportation infrastructure and maintenance

The need for greater investment and funding support from the Government of Ontario for Ontario's municipalities was clearly highlighted in the Report of the "Provincial-Municipal Fiscal and Service Delivery Review – Facing the Future Together". This report highlighted how Ontario's municipalities continue to struggle to keep up with transportation infrastructure demands needed to support their local economies and to ensure the highest possible standard of living and safety for their residents. With a transportation infrastructure investment gap (roads, bridges and transit) between the Government of Ontario and Ontario's municipalities of approximately \$3.8 billion, it is clear that greater funding support is needed for Ontario's municipalities to build the transportation infrastructure needed to support local economies and to sustain the quality of life that Ontarians have come to expect.

CAA (Ontario) and the Ontario Good Roads Association are asking municipalities throughout Ontario to support our call for the Government of Ontario to consider dedicating a portion of the new revenue collected from the provincial portion of H.S.T. charged on gasoline and diesel sales to a new predictable funding mechanism directed to Ontario's municipalities for transportation infrastructure investment. Application of the H.S.T. on gas and diesel sales came into effect on July 1, 2010, effectively applying the former Provincial Sales Tax of 8 percent to gasoline and diesel sales. CAA estimates that the Government of Ontario will collect approximately \$1.53 billion annually in new revenue through the application of the H.S.T. on gasoline and diesel sales.

Since the implementation of the H.S.T., over 7000 CAA members and non-members have shown their support of this initiative by signing CAA's petition and e-petition (at https://www.caasco.com/community/worst-roads/) calling for a

portion of the new revenue collected from H.S.T. on the sale of gasoline and diesel to be dedicated to transportation infrastructure and maintenance. Attaining the support of municipal councils from across the province is the next step in this initiative.

WHEREAS the introduction of the Harmonized Sales Tax (H.S.T.) on July 1, 2010, and its application to gasoline and diesel sales will result in new revenue for the Government of Ontario; and

WHEREAS based on 2010 average price levels of gasoline and diesel, and 2009 average consumption levels in Ontario, the Government of Ontario's projected new revenue will be approximately \$1.53 billion annually; and

WHEREAS the Provincial-Municipal Fiscal and Service Delivery Review identified a transportation infrastructure investment gap between the Government of Ontario and Ontario's municipalities of approximately \$3.8 billion; and

WHEREAS a lack of sufficient funding for essential transportation infrastructure construction, maintenance and rehabilitation has created a situation where many of Ontario's municipalities do not have the financial capacity to construct new transportation infrastructure and conduct the maintenance and rehabilitation needed to sustain existing transportation infrastructure; and

THEREFORE BE IT RESOLVED THAT the Council of the Township of Head, Clara & Maria requests that the Government of Ontario consider directing a portion of the revenue derived from HST charged on gasoline and diesel sales to a new predictable funding mechanism that will allow Ontario's municipalities to make the critical investments needed to be effective stewards of transportation infrastructure; and

FURTHER THAT a copy of this resolution be forwarded to Premier Dalton McGuinty, Hon. Dwight Duncan, Minister of Finance, Hon. Kathleen Wynne, Minister of Transportation, Hon. Bob Chiarelli, Minister of Infrastructure, the Ontario Good Roads Association and to CAA; and

FURTHER THAT this resolution be circulated to all municipalities in Ontario requesting their support.

AMO Supports Accessible Communities

Municipalities have traditionally been at the forefront of efforts to create more accessible communities for all their residents. The Ontario government was committed to a new *Accessibility for Ontarians with Disabilities Act (AODA)* and stakeholders, including AMO contributed to it. The Act requires various regulations and work is progressing.

The Province, on March 18 concluded its consultation on the proposed Integrated Accessibility Regulation (IAR) which deals with transportation, information and communications and employment.

Submissions on the draft regulation now rest with the Minister to consider. We expect the final approved regulation will be issued this spring. The final public review of the built environment regulation has not as yet occurred.

AMO's contribution to the draft IAR focused on obtaining clarification on some of its requirements as well as timing and the municipal context for implementation. Our objective is to support accessibility.

In terms of the broader context, AMO notes that in addition to achieving accessibility, municipalities must provide reliable emergency services, safe roads and bridges, safe drinking water, effective sewage treatment, comprehensive waste management programs and public transit among other services. They must also provide a better quality of life by promoting economic development, recreation and cultural initiatives. Most of the services have regulated performance standards as well, and are required priorities, but unfortunately, resources are not unlimited. Municipal decision-making is multi-dimensional – councils must consider competing priorities. It is within this broader context that municipal governments will continue to work with its communities to advance accessibility in ways that are practical, achievable and affordable.

It will be important for governments, including the province, and others to work together on guidelines, training information and share practices to create efficiencies.

AMO'S ADVICE to the Province on the IAR:

Timelines need to be fair and flexible. Above all, it needs to be recognized that municipal governments across Ontario are different when it comes to size, resources and planning processes.

AMO believes that timelines within the regulation for compliance should be based on

the following considerations:

- · the reality of municipal business planning cycles; and
- the varied human and fiscal resources of municipalities across the province.

Given their more limited sources of revenue and in some parts of Ontario, a relatively greater fragile financial position, municipal governments compliance should be allowed to draw upon the experience of the Ontario Government.

AMO believes that emergency information policies and procedures should be required in 2012 as currently proposed. Full compliance of other programs and services for municipal governments should be required no later than two years after the Ontario government requires compliance for its own programs and services. Learning from the Province's experience and then apply those lessons more efficiently, more cost-effectively and more successfully across the broader public sector.

AMO supports the transit industries recommendations identified in the joint Ontario Public Transit Association/Canada Urban Transit Association submission.

There is concern with the cost implications and impacts of the transportation standards within the IAR will be significant, according to feedback from transit-based members. Current estimates for some smaller transit systems suggest that annual operating costs could increase by 50%. These costs could lead to higher fares, cuts to services and increased property taxes, and they could be significant enough to disadvantage entire communities. Some of the requirements expected to impact transit providers, include fare parity, hours of service and eligibility criteria for specialized services. AMO supports the expectation of affordable and reasonable fares as well as access to services. However, the expectation of public transit providers and non-profits to additionally subsidize and operate services in an already chronically underfunded environment is going to be a significant challenge. The requirements, in fact may act as a disincentive for areas considering developing a transit service.

The amount of funding for transit under the Provincial Gas Tax is reliant on growth in ridership. Without increases in ridership and transit expansion, the yearly funding could be reduced. Transit expansion to serve all ridership has already been compromised by the elimination of the Ontario Bus Replacement program. Additionally, Development Charges Act limits amount for transit. AMO continues to position that funding from the provincial government is required to help implement these important expectations.

The information and communication standards.

It is unreasonable to assume that all municipalities have the resources and capacity to implement the highly technical Web Content Accessibility Guideline 2.0. Implementation with the appropriate time and resources could be hampered. This is an area that would benefit from sharing of experiences and other means to achieve efficiency.

There is still a need to clarify a number of the proposed definitions in the regulation and desired expectations.

Terms, such as "suitable accommodation" is an example of a definition that needs to be clarified. Regulations should provide for clear direction and outcomes. Compliance and enforcement should be informed by clear standards and definitions that are consistent across the legislation's regulatory framework.

Achieving Accessibility Outcomes:

In addition to the societal value, human rights and dignity, there is no doubt an economic benefit results from increased sales or employment taxes, and tourism for example. However, the majority of that revenue will go to the federal and provincial governments, in keeping with how the tax dollar is currently used. Together, the federal and provincial government receive the bulk of that tax dollar. Municipalities receive only 10 cents of each tax dollar. That dime must fund a wealth of services and their concomitant service standards, which are most often set by the other orders of government.

Seemingly, small increases in costs can have significant impacts on local budgets and therefore property taxes, which in turn can require discretionary services to be eliminated or reduced, impacting the entire community including the accessible community. This would be an unintended consequence of the Act's standards and all stakeholders have an interest in avoiding it.

In order to help manage the anticipated investments to implement the new standards, appropriate time to plan for this spending is needed. Municipalities can better manage the implementation of the proposed changes by working within their normal business and budgeting cycles.

In summary, accessibility is a common goal. It is in the best interest of communities to not create new barriers and to remove barriers for people with disabilities and to improve the quality of life of all residents.

The Ontario Ministry of Natural Resources (MNR), Ottawa Valley Forest Inc. and the Local Citizen Advisory Committee advises you that the 2011-2012 Contingency Plan (CP) for the Ottawa Valley Forest has been approved by the MNR Regional Director. The associated April 1, 2011 – March 31, 2012 Annual Work Schedule (AWS) for the Ottawa Valley Forest has been approved by the Pembroke District of the MNR. Both documents are now available for inspection.

Availability

The CP and AWS will be available for public inspection at the Ottawa Valley Forest Inc. Office during regular office hours and the Ministry of Natural Resources public website at **ontario.ca/forestplans** beginning May 18, 2011 and throughout the period that they are in effect. Service Ontario offices provide access to the internet. Implementation of the Contingency Plan and Annual Work Schedule will commence June 1, 2011.

Why is a Contingency Plan Required?

The Contingency Plan is required because there is a delay in the approval of the Forest Management Plan, which is expected to be finalized by August. The CP allows for the implementation of planned forest management activities until the FMP is approved.

Scheduled Forest Management Operations

The Annual Work Schedule describes forest management activities such as harvest, site preparation, tree planting, and tending, as well as road construction, maintenance and decommissioning that are scheduled to occur during the year.

Tree Planting and Fuelwood




