Taxation By-Law Report - 20/05/11/1301									

SUBJECT: Specifics of the 2011 budget by-law.

RECOMMENDATION: That the resolutions be passed adopting the by-law for 2011 taxation so that bills may be produced in enough time for split payments of July and October.

BACKGROUND/EXECUTIVE SUMMARY: The following by-law sections simply amount to the amount of money required to be raised from taxation across the various classes to meet the budget demands as passed in April.

**NOW THEREFORE** the Council of the United Townships of Head, Clara & Maria does hereby enact:

- **THAT** every property owner in the Municipality of the Corporation of the United Townships of Head, Clara & Maria shall be taxed according to the following tax rates and that such taxes shall become due and payable as follows:

- **THAT** 50% of 2010 tax rates for all classes of property are due March 31<sup>st</sup> as per by-law 2011 - 04.
- **THAT** balance owing is to be split into 2 payments due July 29, 2011 and October 28, 2011.
- **THAT** a penalty of 1.25% per month be payable on all overdue current taxes, calculated on the first day of the month;
- **THAT** interest at 1.25% to be added on all tax arrears monthly on the first day of each month.
- **THAT** this By-Law is deemed to come into force and take effect on the 1<sup>st</sup> day of January 2011.
