

"Whereas Municipalities served by the OPP were not involved in contract negotiations between the Province of Ontario and the OPP staff, which resulted in significant wage settlements;

And Whereas these same Municipalities are ultimately faced with the resultant massive cost increases to provide police services to our residents;

And Whereas the average annual cost of living increase over the past 18 years is less than 2%;

And Whereas Municipalities have reached the limit to what the local taxpayers can afford to pay in property taxes;

Now Therefore be it resolved;

That the Municipality of Bayham requests the Province of Ontario and the OPP to reconsider their recent agreement, and include municipalities in contract negotiations;

WHEREAS there is a need to lessen our use and dependency on fossil fuels and increase our sustainability through responsible development of renewable energy resources and conservation;

AND WHEREAS literature reviews by the Canadian and the American Wind Energy Associations (Wind Turbine Sound and Health Effects, 2009-09) and by Ontario's Chief Medical Officer of Health (The Potential Health Impact of Wind Turbines, 2010-05) acknowledge that there is not sufficient scientific evidence to prove that these facilities have a direct negative impact on human health and well-being;

AND WHEREAS there is a growing body of case evidence that they do, and the precautionary principle states if an action or policy has a suspected risk of causing harm, then in the absence of scientific consensus that the action or policy is harmful, the burden of proof that it is not harmful falls on those taking the action;

AND WHEREAS Ontario's regulations do not cite any scientific proof that 40 db(A) hourly average value used as a basis for setbacks in rural areas is sufficient to guarantee the health and well-being of the people in the proximity to these facilities and give no consideration to the Low Frequency component of the noise emissions;

AND WHEREAS more than 70 municipalities throughout Ontario have passed resolutions and bylaws expressing concerns with the Green Energy Act (2009);

AND WHEREAS The Green Energy Act (2009) has excluded municipalities from acting in any direct way to address concerns relating to public interests in comprehensive municipal planning, public health, infrastructure expansion and environmental assessment and thereby limits the ability to manage the impacts of industrial wind power projects directly within the community;

AND WHEREAS Central Huron residents have repeatedly voiced concerns about the density of the IWT's proposed in Central Huron and Huron County as a whole, the associated distribution and transmission network and the cumulative effects on the municipal road system;

AND WHEREAS Central Huron residents have told Council that they do not believe that Ontario's regulations are sufficient to protect their health and well-being or to prevent the devaluation of their properties;

AND WHEREAS any property devaluation will have an undesirable effect on the tax base and hence on Central Huron sustainability;

AND WHEREAS there is now supportable evidence that Ontario does not have the most stringent IWT standards in North America as proclaimed by the Ontario Ministry of Environment;

AND WHEREAS the two IWT projects proposed in Central Huron are bordered by Lake Huron (west), the Maitland River Valley (north), the Bayfield River (south), and the 2,200 ha (5,500 acre) Hullett Provincial Wildlife Reserve (east);

AND WHEREAS these areas contain 2 recognized North American flyways, seasonal migrating paths, daily flight paths and seasonal staging grounds, and all areas provide habitat and breeding grounds for a long list of birds, bats, waterfowl and wildlife; and there is growing concern for the long term effects that IWT's may have on these species, many of whom are on the endangered species list for Ontario;

NOW THEREFORE BE IT RESOLVED that the Municipality of Central Huron requests that the Province of Ontario declare a moratorium on all current and future projects for on-shore and off-shore development of windenergy facilities until it has commissioned properly-designed independent third-party scientific research into the long-term effects, released the findings for public comment, and has incorporated those comments to enact science based maximums for wind facility emissions, and for electrical emission from all related electrical facilities, and can therefore guarantee to Council's satisfaction that the health and well-being of the Municipality's human and animal populations are protected from the direct and indirect negative effects of being in proximity to those IWT facilities.

AND FURTHER BE IT RESOLVED that the Municipality of Central Huron requests local authority to be restored to pre GEA levels to allow the local government to mitigate impacts of renewable energy projects within the community.

The Ottawa River is a seminal piece of our local culture, history, and geography. It is the border between the two largest provinces in Confederation, is the source of drinking water for over two million people, and generates hydro power for both Ontario and Quebec.

On Monday, July 4, Ottawa Riverkeeper launched the Great River Project, a water quality monitoring and community engagement project aimed at improving water stewardship along the Ottawa River. Planned in five stages, the 900 kilometer journey will take an expedition crew from Lac Témiscamingue downstream to the urban shores of Ottawa and Montreal. All along the way we will be testing water quality, identifying pollution sources, and challenging local residents to become dedicated stewards of a river whose health they depend on. Dear Heads of Council and Stakeholders:

Our government has had an ongoing commitment to reforming Ontario's land-use planning system. Our goal is to make our communities places where people want to live, work and invest. This commitment is built on a foundation of the strong policy direction in the Provincial Policy Statement, 2005 (PPS), which came into effect on March 1, 2005.

The PPS sets the policy direction for appropriate development, while protecting resources of provincial interest, public health, and environmental quality. It supports a more effective and efficient land-use planning system.

The PPS provides the foundation for provincial plans such as the Greenbelt Plan and the Growth Plans for the Greater Golden Horseshoe and Northern Ontario. As part of our commitment to the continuous improvement of the policy-led planning system, we have begun the five-year review of the PPS, to determine whether any improvements are needed and to address emerging land-use issues.

While some Ontario communities are growing rapidly, others face challenges, such as the need to diversify their economies or maintain their populations. While the challenges may differ, the principles of strong communities, a clean and healthy environment and a strong economy are common goals. Since 2003, our government has taken a number of important steps to achieve these goals.

These steps included the *Strong Communities* (*Planning Amendment*) *Act, 2004* and the *Planning and Conservation Land Statute Law Amendment Act, 2006*. These legislative changes recognize the need to manage land and resources more effectively and provide municipalities with new planning and financial tools to encourage and support future community planning.

In 2005, we released the Greenbelt Plan which permanently protects 1.8 million acres of working countryside in the Greater Golden Horseshoe. The Greenbelt contains some of the best agricultural land in Canada, valuable natural resources, significant environmental features and vibrant rural communities.

In 2006, our government released the Growth Plan for the Greater Golden Horseshoe and in 2011 we released the Growth Plan for Northern Ontario. These provincial plans outline a vision and policies for where and how these regions should grow to 2031 and 2036, respectively.

#### Heads of Council and Stakeholders

We also introduced a Development Permit System (DPS) which is available to all communities. The DPS is a planning tool that provides municipal councils with an alternate approval system which facilitates and streamlines development, promotes community building and enhances environmental protection. We encourage you to consider implementing a DPS as part of your Official Plan.

#### Resources for Municipalities

The ministry has developed supporting materials describing the planning and financial tools that are available to municipalities. These resources are readily accessible and provided in both hard copy and on-line. We encourage municipalities to utilize these tools when planning for the future of their communities.

Enclosed is a sample publication that you may find useful and I encourage you to visit our website <u>www.mah.gov.on.ca</u> to and download copies and see our complete list of land use planning publications. Also enclosed is a poster which outlines key planning tools that can be posted in your office.

Lastly, if you have any questions, please contact staff at our Ministry's regional Municipal Services Offices, located in Toronto, London, Kingston, Sudbury or Thunder Bay.

I thank you for your commitment and shared vision of strong, vibrant communities across Ontario.

Dear Mayor or Reeve and Council,

Once again, provincial government policies and directives threaten services in your municipality.

The Ministry of Community Safety and Correctional Services has tendered a Request for Proposal (RFP) that would effectively transfer the authority of vehicle impoundments from the Ministry of Transportation to the OPP in the form of RFP OPP-0460. This will have a negative affect on the overall capacity of your local towing industry to serve our community.

This RFP has been tendered without consultation with you,

our municipal representatives, and without us, your local tow service providers. It is designed for the administrative convenience of the OPP, not for the delivery of effective service on our roads. It removes the quality control of competition from the industry equation by creating monopolistic control over the delivery of impound services in 56 zones across the province.

Towers are an essential 4<sup>th</sup> component in keeping the roads safe in every community, but unlike the other 3 components; EMS, Fire and Police, we are strictly within the private domain and so must maintain and keep our equipment available for 24/7 emergency response at our own expense. Tows generated within the community by your contracted police service are an important source of revenue that supports your local towers and allows them to be there 24/7 for the community in times of need.

Simply put, if the OPP are allowed to impose their desire for exclusive, large scale impound lots on our communities, many local towers will eventually be forced out of business, people will have to travel greater distances at greater expense to reclaim their vehicles, and the number of local towers available to serve in times of emergency will be diminished. Not to mention the environmental impact of towing these vehicles the greater distances this plan will impose. It is also important to note that the impound facility for a zone listed in the RFP does not even have to be within that zone, thus creating further hardship and expense for those needing to reclaim an impounded vehicle.

We would urge you to pass a resolution opposing this RFP and the changes it proposes until such time that there has been adequate consultation with the industry, and you, our elected municipal representatives.

We further ask that you send this resolution to other municipalities requesting their support, and that all resolution be sent to the Minister of Community Safety and Correctional Services, so that this dangerous proposition can be halted.

## WHEREAS:

The tick-borne illness known as Chronic Lyme Disease, which mimics many catastrophic illnesses, such as Multiple Sclerosis, Crohn's, Alzheimer's, arthritic diabetes, depression, Chronic Fatigue and Fibromyalgia is increasingly endemic in Canada, but the scientifically validated diagnostic tests and treatment choices are currently not available in Ontario, forcing patients to seek these in the USA and Europe;

## AND WHEREAS:

The Canadian Medical Association informed the public, governments, and the medical profession in the May 30, 2000 edition of their professional journal that Lyme Disease is endemic throughout Canada, particularly in Southern Ontario;

#### AND WHEREAS:

The Ontario Public Health system and the Ontario Health Insurance Plan currently do not fund those specific tests that accurately serve the process for establishing a clinical diagnosis, but only recognize testing procedures known in the medical literature to provide false negatives 45 to 95% of the time;

## NEW RECOVERY PROGRAM LAUNCHED FOR PEOPLE WITH MENTAL HEALTH CONDITIONS

July 14, 2011 — Clients with mental health conditions are benefitting from a new and innovative program developed by the Royal Ottawa Health Care Group in partnership with the Champlain LHIN. The program focuses on recovery, helping people with a mental illness to get on with their lives after a hospitalization or crisis.

Now fully operational, the program is located at the Royal Ottawa Mental Health Centre. It offers life skills training and guidance on how to live responsibly and independently. Thirty-two clients are enrolled at any one time and stay for an average of six months.

"The program helps me see hope in life, and to me that's a big thing," says Luc, 37, a client who lives with severe depression. "At home, I didn't have any structure." Luc takes part in a number of activities including morning exercises, cooking classes, wellness seminars and job skills training. When he returns home, he aims to become a volunteer at a local charitable organization.

Saverio, also 37, explains he was admitted to the recovery program after a hospitalization due to schizophrenia. "I was really a mess, I was working too much and coping with the illness," he says, adding staff at the program taught him "how to put things in perspective, how to organize myself, how to live better and support myself." Saverio now feels he has the confidence to go back to university to complete his degree.

The 32-bed program is a unique model of care in our region that provides solid support for clients who would otherwise fall through the cracks of the health system. Historically, people with mental health conditions were kept institutionalized for years, or abandoned to struggle on their own, often left despairing and homeless. By offering short-term assistance from a variety of health professionals, the new program adds a new level of care that allows clients to transition safely from crisis to recovery and from hospital to home.

This is just one initiative of a larger restructuring effort conducted by The Royal in recent years to better serve the population. The Champlain LHIN provided strong support during The Royal's transformation to ensure resources are reallocated in a way that most benefits the region's residents.

"The new recovery program is an example of how the Champlain LHIN works closely with health-care providers to improve access to a wide range of health services," says Champlain LHIN CEO Alex Munter. "As the demand for mental-health services rises due to lessening stigma, the LHIN is bringing more and more communities and providers together to find creative local solutions to local challenges."

The mental-health recovery program is staffed by a multi-disciplinary team at The Royal that includes psychiatrists, nurses, personal care attendants, occupational and recreation therapists, and a social worker. Clients can be admitted to the program from hospitals across the Champlain region or from home through community agencies.

"It just seems brighter here somehow," says another client of the program, stating the program has helped her plan her days better and become more motivated. "It just feels like there's more sunshine in here."
