1. That a slide be purchased for Old Mackey Park to be installed prior to Canada Day celebrations.
2. That a bench and evergreen tree (to be lighted over the Christmas holiday season) be purchased as soon as possible and installed near the veteran's memorial in Stonecliffe.
3. That some picnic tables be portable (collapsible benches) for easy transport to Old Mackey Park as needed and modified to allow for installation of umbrellas to provide shade.
4. That Council research the possibility of washroom facilities at the Stonecliffe Boat Launch.

5. That Council consider implementing “poop and scoop” supplies at the boat launches and municipal parks.

3. That Council continue to prohibit overnight parking or camping at municipal parks;
4. That Council prohibit fires at all municipal parks and boat launches unless expressly authorized for specific events;
5. That improved signage be installed to communicate Council's decisions;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby agree to incorporate these suggestions into the final draft of the amended by-law;
