**THEREFORE BE IT RESOLVED THAT** the Council of the United Townships of Head, Clara & Maria has received and reviewed a copy of the Canada Day committee minutes and does hereby authorize:

- 1. Municipal staff to help the committee set up and tear down equipment for Canada Day during normal working hours.
- 2. Up to \$240 plus employer expenses to hire short term help for infrastructure purposes before and after the Canada Day event.
- 3. Overnight camping (possibly two nights) at OMP to provide security.
- 4. Staff to relocate the horseshoe pits at OMP to a safer location.
- 5. Up to \$1,000 to be spent on landscaping at OMP including removal of stumps and scrub trees to increase parking.
- 6. Up to \$1,000 of the Recreation Committee budget (miscellaneous) to purchase shelters to be used for Recreation events.
- 7. Up to \$300 from the Parks and Rec budget to purchase a large Canadian flag(s) for OMP.
- 8. Funds required and not otherwise allocated to come from the general surplus realized for 2014.
