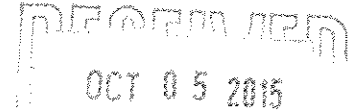

**Happy End of Summer to all:**

I last corresponded to everyone just prior to the annual AMO Conference in August. This is a follow up to that email along with a request for all of you.

The following occurred at the AMO Conference:

1. The Minister of Municipal Affairs and Housing visited the ROMA Board Meeting on the Sunday of the Conference. The issue of the power dam compensatory program was raised with the Minister. It is his understanding that the Ministry of Finance is working on this matter.
2. A question to the Minister of Finance was prepared requesting that no changes be made to the compensatory program through to 2016 as the tax policy work, requested by the Premier was not yet completed. Mayor Glenda McKay of the Township of Greater Madawaska offered (thanks Glenda!!) to ask the question at the Ministers Forum. The Parliamentary Assistant Laura Albanese answered on behalf of the Minister as he was not present.

Ms Albanese indicated that since it was expected that a report would be brought to Cabinet in October 2015 on the tax policy matter, no decision on changes to the compensatory program needed to be made at this time. Given this, the government has left its options open for the fall session. This is a wait and see.

3. A Province of Ontario reception was held at the conclusion of the Ministers Forum. At the reception I had an opportunity to discuss the power dam issue with the Assistant Minister, Mitzi Hunter who is very familiar with the matter. Ms Hunter did say to me that the Province is committed to resolving this issue and was looking forward to the October report.
4. Mayor Glenda McKay, CAO, Alison Holtzhauer (both of Greater Madawaska), myself and Councillor Yvan Besner from Wawa met with Carla Nell of the Municipal Tax Advisory Group (MTAG). The purpose of the meeting was to research the possibilities, subject to a terms of reference, for MTAG to provide technical assistance with respect to the current tax policy work being undertaken by the Ministry of Finance on power dams.

Given that MTAG has been retained for power dam matters concerning current Assessment Review Board work, there could be some real benefits to engaging them in this matter. Many if not all of our communities lack the necessary resources to review and provide detailed comments on a tax policy shift of this magnitude. The results of this process for many of us may greatly impact our future local financial model.

This leads us to a request for the group. Retaining MTAG in this endeavor comes at a cost. Obviously the cost of this will be driven by a Terms of Reference. To that end, can you please inform me if your community is willing to:

1. Participate in this process by providing a portion of the costs to retain MTAG? The costs could be split a number of ways, but I would suggest the fairest way may be for all to pay a proportionate share according to the amount of the compensatory grant they receive.
2. If you are in agreement to point #1 above, would you be willing to work on the stated Terms of Reference?
3. It will be necessary that only those who participate financially will be privy to the work by MTAG.

It is imperative that we move forward on this as soon as possible. To that end, I would ask for your response as soon as possible.

Dear Mr. Voisine:

Our municipality supports the efforts of the Mayor of the City of Pembroke and the Warden of the County of Renfrew to discuss the addition of bus routes in the Deep River to Ottawa corridor. We request Greyhound market the benefits of bus travel to our residents and businesses.

The present time slot the bus service is offered is problematic and we feel has likely caused bus service to be under utilized by visitors, residents, employees, day travellers and our local business community. A review of ideal travelling times and marketing the service may result in an increase in the overall usage of the bus service.

For generations, the bus service has provided many of our residents across the county with the opportunity to travel to other communities within Renfrew County, Ottawa and Eastern Ontario for medical, family and business appointments. The same day travel, when there was a more fulsome route time selection offered, made it a convenience worth considering and supporting. A number of smaller businesses and even some of our larger businesses utilized the parcel/document pick up and drop off as it often was one day or overnight service.

Our Council and our community would request you take advantage of the offer of Mayor Lemay and Warden Emon in the email dated Tuesday, October 6, 2015 to introduce you to our larger community and the individual communities. The email suggested that hospitals, Ontario Disability and Ontario Works staff, seniors groups, Home Support organizations, Probation Services and Child Protection services utilize the service. It mentioned medical and social services which might now consider services in other adjoining communities if their clientele can cope/utilize the bus system with a better schedule. The offer from the Mayor and the Warden will assist you as you attempt to make Greyhound service a relevant component of travel in Renfrew County.

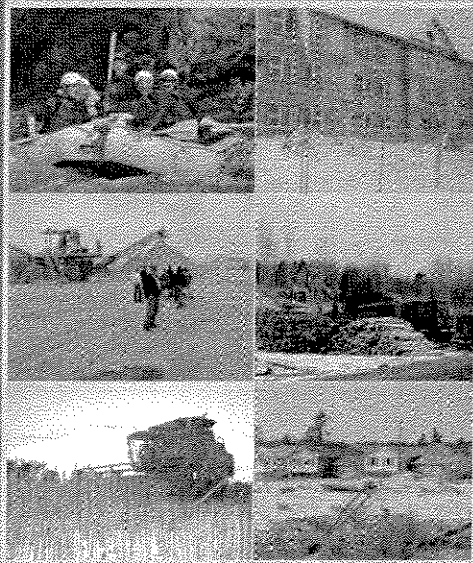
