# Northern Graphite – Request to Use Unopened Road Allowances- Report #13/11/15/1101

#### **Subject:**

Response to request from Northern Graphite for use of Unopened Road Allowances

## **RECOMMENDATION:**

That Council refer this draft to legal counsel.

**WHEREAS** an agreement for the use of a mining company of unopened municipal road allowances is uncharted territory with the potential for unforeseen challenges;

**AND WHEREAS** consult with the County planning department recommends seeking legal opinion;

**THEREFORE BE IT RESOLVE THAT** the Council of the United Townships of Head, Clara & Maria does hereby authorize staff to refer this issue to the municipal solicitor for agreement review and advice.

## **BACKGROUND/EXECUTIVE SUMMARY:**

Pretty self-explanatory. Not having any experience with this type of request advice was sought from the county planning department.

They pointed out that significant areas of concern which were not addressed include:

- 1. Right to terminate and notice period;
- 2. Protection of environment on our lands;
- 3. Need to acquire all necessary permits;
- 4. No obligation to provide the suggested donation annual fee should be outlined;
- 5. Insurance certificate;
- 6. 3<sup>rd</sup> party liability protection ATV user/or staff injured on road allowance once cleared?
