**WHEREAS** the Municipality of Niagara Region has requested support in its lobby to the province to increase testing and treatments for Lyme disease;

**AND WHEREAS** the Council of the United Townships of Head, Clara & Maria does agree that this disease has long term detrimental consequences which may be better managed through improved testing and treatment;

**THEREFORE BE IT RESOLVED THAT** this Council does hereby join in that request and asks that the Premier of Ontario, through the Minister of Health and related associations move to increase response to this growing problem.

iii. Report #10/06/16/1103 – Support – Tay and Insurance Changes Resolution #10/06/16/007

Moved by Councillor Foote and Seconded by Councillor Grills

**WHEREAS** the Corporation of the Township of Tay is requesting that the province make long term comprehensive changes to the current insurance system in Ontario including amendments to joint and several liability insurance;

**AND WHEREAS** this Council has supported and requested amendment in the past and continues to do so recognizing that amongst many other situations, with the current lack of auto-extrication services within our boundaries, the municipality is exposed to the potential for liability, without fault or responsibility, simply due to joint and several liability;

**THEREFORE BE IT RESOLVED THAT** The Council of the United Townships of Head, Clara & Maria does hereby join with the Township of Tay to request that the province take immediate steps to change the existing insurance scheme in Ontario, amending joint and several liability removing the significant burden on municipalities and ratepayers due to high tax rates in part due to increased premiums as a result of litigation and claims costs.

**WHEREAS** Council has received and reviewed background information provided by MPP Laurie Scott;

**AND WHEREAS** human trafficking is a heinous crime that has been referred to as modern day slavery;

**AND WHEREAS** human trafficking is one of the fastest growing crimes that starts and stays in Canada, targeting victims – 90 percent of which are Canadian-born and predominantly female, averaging the age of 14;

**AND WHEREAS** Ontario is a major hub of human trafficking in Canada, and victims are lured, manipulated and coerced, often over the internet from every part of Ontario;

AND WHEREAS human trafficking is in our neighbourhoods and our communities;

**THEREFORE BE IT RESOLVED THAT** the Council of the United Townships of Head, Clara & Maria support Bill 158, *Saving the Girl Next Door Act, 2016*, support MPP

Laurie Scott's motion for a multi-jurisdictional and coordinated task force of law enforcement agencies, Crown prosecutors, judges, victims' services and frontline agencies;

**AND FURTHER THAT** a copy of this resolution be forwarded to the Premier of Ontario, our MPP John Yakabuski and county municipalities for support.

v. Report #10/06/16/1105 – Support – South Algonquin and Wolf Harvest Resolution #10/06/16/009

Moved by Councillor Chartrand and Seconded by Councillor Foote **WHEREAS** the Municipality of the United Townships of Head, Clara & Maria is one of the 39 municipalities referred to in the resolution of the Municipality of South Algonquin concerning the ban of the harvest of wolf and coyotes outside of Algonquin Park;

**AND WHEREAS** anecdotal evidence suggests that there has been a significant increase in the wolf and coyote populations within our municipality based on the reported number of human/pet and wolf/coyote encounters;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby support the position of the municipality of South Algonquin and the enclosed resolution and requests that the province through the Ministry of Natural Resources and Forestry reconsiders its current position and rescinds the ban on harvest of these animals placing adequate consideration on public safety during debate.

**AND FURTHER THAT** copies of this resolution be circulated to county municipalities for support as well as John Yakabuski MPP, Renfrew-Nipissing-Pembroke, Laurie Scott MPP, Haliburton-Kawartha Lakes-Brock, Norm Miller MPP, Parry Sound-Muskoka and Vic Fedeli MPP, Nipissing.

vi. Report #10/06/16/1106 - Employee Remuneration/Salary Grid Adjustment

Resolution #10/06/16/010

Moved by Councillor Foote and Seconded by Councillor Grills

**WHEREAS** the municipal employee salary grid was last adjusted in 2013 and requires at least a two year review to ensure parity to comparable external market wages;

**AND WHEREAS** national salary increases across all areas have amounted to 3-4% per year over the past three years;

**AND WHEREAS** the employee grid compared to information received from the County Salary Review, using rates for Townships only and not the larger towns, shows individual positions differing from between 8 to 56 percent;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby approve a salary increase, across the grid of \_\_\_\_\_% to attempt to bring Head, Clara & Maria staff salaries closer to fair market values, considering that our situation is not the same as some of the others quoted;

AND FURTHER THAT individual employee pay adjustments be made as per their position on the pay grid as of January 1, 2016 and paid retroactively to that date.

**WHEREAS** the employee salary grid review completed in 2010 recommended annual pay scale reviews to increase employee salaries to be more competitive with neighbouring municipal salaries;

**AND WHEREAS** it has been determined through evaluation of the County Salary Survey that Head, Clara & Maria employee salaries are in some cases the lowest in the county and in others next to lowest with the high range in HCM salaries lower than the low range for the majority of comparable positions;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby agree to increase the employee salary grid for the employees of the Municipality of the United Townships of Head, Clara & Maria as follows in an effort to take steps to begin to decrease the gap between HCM employee salaries with those of other local municipal employees;

2.	Level 2
3.	Level 3
4.	Level 4
5.	Level 5
6.	Level 6
7.	Level 7
8.	Level 8
9.	Level 9

AND FURTHER THAT individual employee pay adjustments be made as per their position on the pay grid as of January 1, 2016 and paid retroactively to that date.

\*Consider 4-5 year adjustment to compensate people at job rate. Ideally to be completed at mid-term of Council.

vii. Report #10/06/16/1107 - Merit and Bonus Policy Amendment Resolution #10/06/16/011

**WHEREAS** Head, Clara & Maria has existing policy on merit pay and bonuses which has not been utilized since its inception in 2012 in part due to ambiguities and difficulty of use;

**AND WHEREAS** a simple adjustment and addition to the current guidelines would make the policy easier to use;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby adopt the proposed Merit Increase Grid as an addition to the Policy on Merit and Bonus Awards adopted in 2012 and authorizes staff to implement the grid retroactively to January 2016 for the 2015 employee performance appraisals.
