# Commercial Logging in Algonquin Park - Report #05/12/14/1407

#### Subject:

The content of the October Environmental Commissioner of Ontario's report entitled: "Managing New Challenges" recommending the end of harvesting of timber in Algonquin Provincial Park.

#### RECOMMENDATION:

That Council adopt the following resolution is support of MPP John Yakabuski's letter to the Minister of Natural Resources and Forestry and the resolution of the County of Renfrew of October 29, 2014.

**WHEREAS** local residents and the county economy rely heavily on the commercial logging operations in Algonquin Park;

**AND WHEREAS** the elimination of those jobs would be economically debilitating for local residents, ratepayers and other county municipalities;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby fully and whole heartedly support the positions of both MPP John Yakabuski in the attached letter to the Minister of Natural Resources and Forestry and the County of Renfrew's resolution calling for the Minister to disregard the recommendation of the Environmental Commissioner of Ontario as it relates to logging in Algonquin Park;

### Commit to End Logging in Algonquin Park

Toronto, 7 Oct. 2014 – Ontario's Environmental Commissioner says the government should commit to end logging in its flagship provincial park.

In his 2013/14 Annual Report "Managing New Challenges" released today, Gord Miller pointed out that logging is banned in all of the other 338 provincial parks in Ontario. "Algonquin is Ontario's oldest provincial park," says Miller, "and it's high time that we brought it in line with modern values. Right now, it does not even qualify as a protected area under international standards."

The Environmental Commissioner says there are more than two thousand kilometres of logging roads in Algonquin Park and several thousand kilometres more of abandoned ones. "These roads cause a number of problems in the Park, damaging habitat, harming wildlife and acting as pathways for invasive species."

The government recently reduced the area of the park open to logging, but almost two-thirds of Algonquin is still potentially open to timber harvesting. (See map on next page.) Miller says logging in Algonquin is unnecessary, as there is an ample wood supply in the areas outside of the park.

"I am deeply disturbed that Ontario's flagship park continues to receive the lowest level of protection of any of the province's protected areas. This flies in the face of the *Provincial Parks and Conservation Reserves Act, 2006*, which says that ecological integrity should be the top priority for managing and operating all parks."



Dear Minister Mauro,

I am writing you in response to the Environmental Commissioner of Ontario's report released earlier this week entitled: "Managing New Challenges". Among other things, Mr. Miller recommends that the harvesting of timber in Algonquin Provincial Park should no longer be allowed. I wanted you to know—in no uncertain terms—that I find this suggestion reckless and completely unacceptable.

The phasing out of commercial logging in Algonquin Park over the next 10 years would be a devastating blow to the people of my county and would negatively impact the entire economy of Eastern Ontario. My riding was hard hit during the economic recession and adopting this recommendation would hurt the still fragile regional economy. Thousands of jobs in surrounding communities would be lost and many more people in my riding would be indirectly affected by the closing of timber harvesting in Algonquin.

It is also worth noting that just last year your Ministry went through a comprehensive process looking at this very issue. As you well know, in the *Algonquin Park Management Plan Amendment* another 100,000 hectares were declared protected land and closed to timber harvesting. However, the most important aspect of your Ministry's report was that—although it reduced the amount of land where harvesting was allowed—it clearly affirmed that logging should continue and the status quo be maintained.

The practice of an ecologically sound timber harvest has benefited Algonquin Park in many ways. The systematic harvesting of timber in the park has irrefutably proven to reduce the frequency of forest fires. Moreover, it is the logging roads that your Ministry uses to fight fires when they do occur. Your department ensures that these roads are maintained at the highest standards—something which benefits both loggers and conservation officers alike. With stringent management practices the forest industry

works with the Ministry of Natural Resources to ensure that this renewable resource will be available in the park for another 120 years.

Algonquin Park is a great natural resource for visitors in part because its wide geography is easily accessible due to the logging roads within it. This has resulted in a huge benefit for the millions who go to it. It is because of this self-evident fact that only a tiny fraction of recreationalists complain about the timber harvesting that goes on. This is one of the many reasons why the park needs to remain a multi-use area.

In light of the growing opposition to the Environmental Commissioner's recommendation that Algonquin Park be closed to timber harvesting, I am stressing to you the absolute necessity in declining Mr. Miller's unreasonable request. Furthermore, the Government must make it clear that it fully supports the ecologically sound timber harvest which supports tourism, local communities, and a way of life for those in the forest industry.

I look forward to seeing your public support for the people in my riding, loggers, and the great majority of visitors who all benefit from Algonquin Provincial Park and would be happy to speak with you on this urgent issue at your earliest opportunity.

## RE: Environmental Commissioner of Ontario's Annual Report Affects Commercial Logging in Algonquin Park

Please be advised that Renfrew County Council passed the following resolution at its October 29, 2014 session:

"WHEREAS seven communities in Renfrew County have substantial employment related to the forest industry and wood processing facilities that receive a significant portion of wood volume from Algonquin Park. Many of these businesses are multi-generational, with the longest running in its 7<sup>th</sup> generation, and are heavily invested in the sustainability of forestry in Algonquin Park;

AND WHEREAS over 2,700 jobs are directly associated with wood harvested from Algonquin Park and an additional 8,000 jobs are indirectly associated with the support of these activities;

AND WHEREAS approximately 40% of wood volume harvested from Algonquin Park is delivered to Renfrew County wood processing facilities;

AND WHEREAS logging has occurred in Algonquin Park for over 180 years, in harmony with the protection of other forest values, and continues to be a thriving ecosystem that almost one million people visit annually to enjoy;

AND WHEREAS sustainable forest management on Crown land goes hand-in-hand with maintaining ecological integrity, is science-based, heavily scrutinized and monitored for compliance to rules and regulations by the Ontario Ministry of Natural Resources and Forestry, an Independent Forest Auditor, and in the case of Algonquin Park, a third-party certification system;

AND WHEREAS forestry in Algonquin Park ensures that ecosystem processes limited through human intervention (e.g. fire suppression) are emulated, so that forest types and wildlife habitat can occur at natural levels;

NOW THEREFORE BE IT RESOLVED THAT the Corporation of the County of Renfrew request that the Minister of Natural Resources and Forestry not consider the Environmental Commissioner of Ontario's recommendation to commit to the end of commercial logging in Algonquin Park;

AND FURTHER THAT the Minister of Natural Resources and Forestry also be requested to permanently protect sustainable forest management in Algonquin Park;

AND FURTHER THAT the Warden, on behalf of the County of Renfrew, have a meeting with the Environmental Commissioner of Ontario to discuss his recommendation;

AND FURTHER THAT a copy of this resolution be sent to the Premier of Ontario; Minister of Natural Resources and Forestry; Gord Miller, Environmental Commissioner of Ontario; all local municipalities in the County of Renfrew; other municipalities reliant on forest management in Algonquin Park; John Yakabuski, MPP Renfrew-Nipissing-Pembroke; and all forest industries in the County of Renfrew."
