**WHEREAS** the taxation and accounting software being used by staff began to present operational challenges early in 2016 leading staff to begin to research alternatives;

**AND WHEREAS** time is of the essence and a replacement product is required as soon as possible staff signed an agreement to purchase MuniSoft in January;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head. Clara & Maria does hereby retroactively authorize staff to spend up to\$15,000 for the purchase of new software with annual operating costs of approximately \$5,000.

**WHEREAS** Head, Clara & Maria was successful in obtaining funding through and is required to enter into an amendment to the existing contribution agreement for the Canada 150 Community Infrastructure Program (CIP 150) for updates to Old Mackey Park:

**AND WHEREAS** Annex 1 to the Contribution Agreement for Project 809935 – entitled "Rehabilitation of Municipal Park Amenities and Infrastructure" will include:

- Installing motion activated solar lights and security cameras;
- Upgrading the path(s) leading to the washrooms;
- Renovating the outhouse: replacing wooden walls with concrete precast, building new toilets and hooks; and
- Installing bear proof garbage and recycling bins; water source, a sink and a vanity.

**AND WHEREAS** the FedDev Contribution will amount to \$17,349, with a Council commitment of \$34,687.

**AND WHEREAS** Council is committed to funding and delegating authority for entrance into the contribution agreement with the Federal Economic Development Agency for Southern Ontario (FedDev Ontario);

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby authorize the contribution agreement for the project as identified above including Annex 1 to the agreement and further delegates authority for implementation of this agreement and project to the Clerk/CAO Melinda Reith.

**WHEREAS** the Ministry of Municipal Affairs and Housing has proposed a change to the Building Code, B-08-09-03, requiring mandatory five year septic tank pump out and records retention by the owner;

**AND WHEREAS** that same change requires Municipalities to administer and enforce this change;

**AND WHEREAS** the change document fails to identify the administrative costs to Municipalities;

**AND WHEREAS** the change document fails to identify any transfer of Provincial funding to offset these downloaded costs;

**AND WHEREAS** many Municipalities already have bylaws to regulate septic systems especially near waterways;

**AND WHEREAS** the majority of homeowners pump out their septic tanks on a regular basis whether regulated to or not;

**AND WHEREAS** there are many more important issues on which to spend taxpayer's money than "enhancing" maintenance on existing functioning systems;

**AND WHEREAS** adequate legislation already exists to correct malfunctioning systems;

**AND WHEREAS** Premier Wynne stated on Monday, January 30<sup>th</sup>, 2017 at the ROMA conference that the Province recognizes that "one size fits all" solutions do not always work in rural Ontario;

**THEREFORE BE IT RESOLVED THAT** the Council of the United Townships of Head, Clara, and Maria does hereby request the Honorable Bill Mauro, Minister of Municipal Affairs, to rescind proposed Building Code change B-08-09-03;

**AND FURTHER THAT** a copy of this resolution is sent to the Honourable Kathleen Wynne, Premier of Ontario, the Honourable Bill Mauro, Minister of Municipal Affairs, Mr. Patrick Brown, Leader of the Progressive Conservative Party, Ms. Andrea Horwath, Leader of the New Democratic Party, and all Members of Provincial Parliament in the Province of Ontario.

**AND WHEREAS** the Library Board has been contacted to determine its interest and participation in collaboration in this project;

**AND WHEREAS** it is proposed that a student is hired to work under supervision of municipal staff with library personnel providing specific training;

**THEREFORE BE IT RESOLVED THAT** the Council of the United Townships of Head, Clara & Maria does hereby authorize the Clerk, Melinda Reith to apply for funding for a summer student position, whose purpose it will be to archive materials through the Library Board History Project and if time allows to assist in archiving municipal documents;

**AND FURTHER THAT** the wage for this position is increased to \$12.00/hr and the term from 6 to 8 weeks at a cost the municipality of \$1,202.52;
