Timothy Hutchison – President, Municipal Insurance Services

Largest brokerage in Northern Ontario; they have an exclusive partnership with JLT.

We have entered into a hard market where fewer companies are willing to provide insurance and premiums have increased. However, they are working with JLT to keep rates low, and are able to do so because of the size of the JLT.

Coverage remained the same from last year with only a slight increase in premiums. Council may want to consider cyber/ransomware insurance to protect against viruses that may take over computer and hold information ransom. Coverage would cover the expenses to have an expert to come in and unlock the data or pay the ransom to have the information unlocked. May be required to make sure that municipal and resident's information is protected.

Snowplowing for seniors – sensitive area, can increase exposure to slip and falls. Not something they would recommend to municipalities, however the insurance policy would cover any claim. The municipality is increasing their risk due to slip and fall, property damage and increase risk of claims which could lead to increased premiums depending on circumstances. If Council decides to proceed with providing this service, they should set guidelines as to who qualifies for the service and limit their exposure, maintain documentation that minimum maintenance standards were kept up and document each time a property is plowed noting when it was done, that it was done properly, any issues etc. If Council proceeds, ensure that the insurer is contacted to ensure that the coverage is suitable etc.

Municipal Liability consuming alcohol on municipal property – covered if something happened and someone comes back on you. If we are providing the alcohol it is covered. It will depend on the exact circumstances. Is there is an incident and they come back onto the municipality it will be covered under our current insurance.

Can extend coverage for anyone who is renting the hall to include alcohol liability “special event insurance” should have insurance that they purchase on their own – 2 million at least – approximately \$150-200. Can have this included to our policy at an approximately \$1100 and then the municipality charges a cost at the time of the rental.
