#### **Deputation Notes**

## Deep River and District Hospital Foundation - Chris Doucette

There is a need to replaced outdate hospital equipment throughout Ontario, with little to no funding provided from higher levels of government. There has been an identified need for diagnostic imaging equipment replacement, specifically for the Deep River Hospital.

X-ray equipment's typical life expectancy is between 10 and 15 years. The current portable x-ray machine at the Deep River Hospital is 24 years old and the fixed machine is 12 years old.

Because there is no government funding available to purchase new capital equipment, or repair existing equipment, there is a need for community financial support. The DRDHF's mission is to raise funds for equipment to sustain the exceptional services offered at the Deep River and District Hospital.

Their Focused on You Campaign has raised 1.31 million dollars to date which represents 75% of the 1.75 million dollar goal. One million dollars in revenue has been raised from Catch the Ace. This funding will be utilized to purchase a new x-ray machine, a portable x-ray unit and an ultrasound scanner.

## Missing Link Snowmobile Club - Todd Dowser

The MLSC is looking to potentially partner with the municipality to store their groomer at the Deux Rivieres Salt Shed. The front of the groomer needs thawing over the winter and requires power hook-up and a fuel supply. Fuel tanks will need to be relocated to the Salt Shed, and the insurance to cover the liability of the fuel tanks will be covered by either MLSC or OFSC. The salt shed requires roof replacement and electrical hook-up. MLSC is interested in offsetting some of these costs in exchange of a five year lease. The intention is that it will not be at a cost to the tax payers. It may be a win – win for both parties.

The space may also be shared between both parties, as the municipality stores stages etc. there currently. Because the Salt Shed is 25ft long, and the groomer and drag is a combined 42.5 feet, the groomer will be parked in the shed without the main doors being fully closed and locked.

Running low on time as winter is quickly approaching.
