Is there a By-Law appointing Wishart Law Firm as our legal counsel? **Action: Clerk to verify.** 

Have received complaints about docks and boat launches; it is difficult to take boats out of the water at Stonecliffe.

Was there a permit from the Ministry to create break wall on east and west side of the launch? Can we use rock that is already in place? Councillor Allen suggests taking photos for applications now, before water rises, as it could help speed up the application process.

# Bill Bishop – Dementia Friendly Communities

The Dementia Friendly Communities Program has been established here and all over the country in order to create an environment where people with dementia can be participating members of the community.

People with dementia suffer from memory loss which causes them to become frustrated and withdraw from the community, becoming isolated.

This disease occurs over a long period of time – over 10 years easily.

It is important for people with dementia to continue interacting with their community. Those who have dementia still want to be involved in the community- groceries, golf, banking etc.
