



#### RESOLUTION 0144-2022 adopted by the Council of The Corporation of the City of Mississauga at its meeting on July 6, 2022

Whereas the Ontario AMBER Alert is a warning system that quickly alerts the public of a suspected abduction of children who are in imminent danger;

Whereas the goal is to broadcast as much information about the child, the abductor and suspect vehicles as quickly as possible so the public can respond with any relevant information that might lead to the child's safe return;

Whereas people are encouraged to share the AMBER Alert with as many people as possible. If a child or vulnerable person is abducted, spreading the information quickly is critical to their safe return;

Whereas an AMBER Alert makes the public aware to keep an eye out for the child, vulnerable person, suspect and the vehicle described in the alert. If they spot them, try to gather as many details as they can, including the specific location where they saw them, the time, the direction they were travelling in and any other identifying details that will help to locate them;

Whereas an AMBER Alert gives citizen's instructions to call 9-1-1 or the phone number included in the alert immediately if they have a tip or a sighting related to an AMBER Alert.

Whereas an AMBER Alert will only be activated if the police have confirmed that an abduction has taken place; and the victim is a child or a person of proven physical or mental disability; and, there is reason to believe the victim is in danger of serious physical injury, and there is information available that, if broadcast to the public, could assist in the safe recovery of the victim.

Whereas it is essential to remember that an AMBER Alert is not always appropriate in every circumstance and that their continued effectiveness depends on ensuring that they are only used in cases that meet the above criteria;

Whereas the recent tragic death of 11-year-old Draven Graham showed that the AMBER Alert system is flawed when it comes to vulnerable children who can go missing but are not abducted;

And whereas it is clear that there needs to be an addition to the alert system to allow for law enforcement to send out an alert for vulnerable children who go missing under circumstances that do not involve an abduction but are at serious risk of injury or death;

Therefore be it resolved that the Council of the City of Mississauga endorse the following;

- 1. That the Minster of the Solicitor General and the Commissioner of the Ontario Provincial Police, as well as the Premier's Office, be requested to make the necessary changes to the AMBER alert system and create a new alert called the Draven Alert, which will protect vulnerable children who have not been abducted but are at high risk of danger, injury or death and alert the public that they are missing.
- 2. That this motion be sent to all municipalities across Ontario and the Association of Municipalities Ontario (AMO) for endorsement.

#### Re: Ontario Wildlife Damage Compensation Program

We are writing to you today on behalf of our municipality regarding the administration fees related to wildlife damage claims. This program is necessary to protect our farm producers from the devastating losses incurred when they lose livestock to predators.

At the June 28, 2022 Regular Council Meeting the attached Resolution was passed by Council.

Our Council's concern is the administration fee paid to municipalities to administer the program on the Ministry's behalf which was recently increased from \$30.00 per claim to \$50.00 per claim.

We have recently contracted for a new Livestock Investigator resulting in the following costs directly related to wildlife claims:

Hourly Rate: \$25.00/hour Mileage Rate: .50/km

On the most recent invoice for this service there were three wildlife claims with costs as follows:

- 1. April 28, 2022 3 hours + mileage = \$95.00
- 2. May 5, 2022 2.5 hours + mileage = \$75.00
- 3. May 8, 2022 3.5 hours + mileage = \$120.00

There is also time spent by municipal staff in preparing the wildlife claims for submission and monitoring the claims for payment to the livestock owner.

This results in a loss on each wildlife claim for our taxpayers to bear to be able to provide this necessary service to our farm producers.

We respectfully request that the Ministry consider increasing the administration fee on wildlife claims to help offset the increasing costs associated with Livestock Investigation.

We look forward to hearing from you about this matter at your earliest convenience.

Re: Physician Shortages in Ontario

Ontario has one of the most revered health care systems in the world. The residents of Ontario have been fortunate to have access to medical professionals from all branches of the medical field.

Our Province continually monitors the needs of its citizens and strives to make progressive changes to continue to meet the needs of Ontarians. Evidence of this progressive action on the part of the government was the identification of the shortage of Personal Support Workers. Recognizing the vital role that they play in health care, the Province supported Ontario colleges in providing free tuition for students who agreed to study for and become Personal Support Workers. We applaud the Province for this progressive action.

Like many municipalities, we have noticed that as each year goes by, we begin to see fewer physicians. The shortage is becoming alarming as we hear daily that many people are without a physician and do not have access to a primary medical care giver. The shortage of physicians is reaching our hospital emergency rooms as many in our rural communities are forced to close periodically as there are no physicians to staff them.

Another issue which is exacerbating the physician shortage is the limited spaces available in Canadian Universities for medical school and in residency programs. Increases to the number of students who are accepted could go a long way to ensure that more students graduate and become contributing physicians in our communities.

A third issue that causes concern is the seemingly onerous process for foreign and international physicians to become accredited to practice in Ontario. We have had interactions with individuals who have come to our community and are accomplished physicians but are not able to practice in Ontario as they at times cannot afford the cost for accreditation and in other instances, the process is quite lengthy meaning that they must take other positions, outside of their field, thus wasting their talent.



The Town of South Bruce Peninsula has seriously contemplated all of these issues and has taken steps to address the shortage experienced in our community. Council has monetarily supported a local Physician Recruitment Committee and has held money in reserves to assist with the hiring of a recruiter and to be used to assist new physicians requiring funds to set up an office and find housing.

We are reaching out to you to ask for your assistance in addressing the physician shortage. We would like to see subsidy opportunities for students who commit to becoming practicing physicians and would expect that the Province would put protective measures in place to ensure that students receiving funding commit to practicing in Ontario. We would support an expedited accreditation process for foreign physicians. We would encourage the increase of additional student spaces in medical school and residency programs.

The Town of South Bruce Peninsula is not alone in its convictions to address the physician shortages. We welcome you to contact us directly to have conversations about how all levels of government can work together to end this shortage.

## Excerpt from Council Meeting Minutes – July 19, 2022

#### 23. Notice of Motion - Mayor Jackson - Physician Subsidy

Mayor Jackson explained the meeting with the Physician Recruitment Committee and how a retired recruiter is willing to help the Committee but that we need to support medical students. The motion would be forwarded to the Minister, the Premier, the Prime Minister and all Ontario municipalities.

Discussion included the closing of hospital ERs, people without family doctors, the difficulty for professionals to obtain accreditation to work in our Province, having levels of accreditation to relieve pressure, community health models including nurse practitioners, ideas that the recruiter has and how she recruited 77 doctors.

It was Moved by J. Jackson, Seconded by K. Durst and Carried

Whereas the Province of Ontario and particularly rural areas such as South Bruce Peninsula, are experiencing a severe shortage of physicians, leaving many people without access to medical care:

**And whereas** when the Province of Ontario realized the shortage of Personal Support Workers, they took progressive action to support Ontario colleges to provide free tuition for students who agreed to enter into this field of study and work;

**And whereas** it is recognized that the education costs for a physician can be a deterrent for students contemplating entering the medical field;

**And whereas** the Town of South Bruce Peninsula has taken steps to support the recruitment of physicians by earmarking money to hire a recruiter, by monetarily supporting a recruitment Committee and by providing money for new physicians to use to set up office space and for housing;

**Now therefore** be it resolved that the Town of South Bruce Peninsula respectfully requests that the Province of Ontario and Government of Canada recognizes that the shortage in health care workers is not unique to Personal Support Workers but is also relevant to physicians including specialists and general practitioners;

And that in order to support Ontario municipalities and their residents, the Provincial and Federal Governments take steps to provide support and subsidy to students entering

medical school with the intention of becoming practicing physicians in the Province of Ontario and particularly in underserviced rural and northern municipalities;

And that the Provincial and Federal Governments work with Canadian universities to increase the number of students accepted into medical school and residency programs;

And that the Province expedites the accreditation process for foreign medical practitioners:

And further that the Town of South Bruce Peninsula supports whatever protective measures the Provincial and Federal Governments place on the subsidy given to ensure that the students receiving the funding become practicing physicians in the Province of Ontario.

Motion 10.1 - Councillor Humfryes; Re: Private Member's Bill C-233 "Keira's Law"

Please be advised that this matter was considered by Council at its meeting held on May 24, 2022, and in this regard, Council adopted the following resolution:

Whereas violence against women is a Canadian public health crisis that demands urgent action; and

Whereas one in four women experience domestic violence in their lifetime. One woman or girl is killed every other day, on average, somewhere in our country; and

Whereas the most dangerous time for a victim of abuse is when she separates from her partner. According to research from the U.S. Centre for Disease Control and Prevention, when there is a history of coercive control, violence and a recent separation, a woman's risk of domestic homicide goes up 900 times; and

Whereas the current Canadian court system is not equipped to protect women. According to the National Judicial Institute, there is no mandatory education for Judges on domestic violence. Judges need education on what constitutes domestic violence or coercive control. A formal education program would ensure

another line of defense for victims, as well as preventing violence and abuse before it happens; and

Whereas the COVID-19 pandemic has only exacerbated the domestic violence crisis. Women's shelters and crisis centres have reported a marked increase in requests for services this year. The concerns for children are significant. According to recent research from The Children's Hospital of Eastern Ontario, doctors have seen more than double the number of babies with serious injuries as this time last year. These include head injuries, broken bones or in some cases death. Institutions across the country are reporting a similar trend; and

Whereas, according to Article 19 of the UN Convention on the Rights of the Child, children must be protected from "all forms of physical or mental violence, injury or abuse, neglect or negligent treatment, maltreatment or exploitation, including sexual abuse, while in the care of parent(s), legal guardian(s) or any other person who has care of the child." Our current family justice system often fails our children in this regard; and

Whereas, in worst case scenarios, children are killed by a violent parent. As reported by the Canadian Domestic Homicide Prevention Initiative, recent separation and domestic violence are the two biggest risk factors for domestic violence related child homicides; and

Whereas custody disputes are an additional risk factor. Each year in Canada, about 30 children are killed by a parent. Mothers are responsible about 40 per cent of the time, often due to postpartum depression or mental illness. In the 60 per cent of cases where fathers are the murderers, anger, jealousy or post-separation retaliatory revenge are the usual motivations; and

Whereas Keira's Law is named after four-year-old Keira Kagan, who was killed while in the custody of her father, in 2020; and

Whereas many cases of domestic violence are inappropriately labelled as "high conflict" in the family court system. According to research by Rachel Birnbaum, a Social Work Professor at the University of Western Ontario who specializes in child custody, approximately one third of cases called "high conflict" by the court had substantiated evidence of valid concerns about domestic violence. These cases must be recognized and treated differently by judges; and

Whereas voting in favour of "Keira's Law", contained in Private Member's Bill C-233, will not only protect victims of violence and children, it will save lives by

amending the *Judges Act* to establish seminars for judges on intimate partner violence and coercive control;

- Now Therefore Be It Hereby Resolved That Aurora Town Council calls upon the House of Commons to support Member of Parliament Anju Dhillon's Private Member's Bill C-233, that will raise the level of education on domestic violence and coercive control for federally appointed Judges; and
- 2. Be It Further Resolved That a copy of this resolution be sent to: The Right Honourable Justin Trudeau, Prime Minister of Canada; The Honourable Karina Gould, MP, Minister of Families, Children and Social Development; The Honourable Candice Bergen, Interim Leader of the Conservative Party of Canada; Yves-Francois Blanchet, MP, Leader of the Bloc Quebecois; Jagmeet Singh, MP, Leader of the New Democratic Party; MP Tony Van Bynen; and MP Leah Taylor Roy; and
- 3. Be It Further Resolved That a copy of this resolution be circulated to all Ontario municipalities and the Federation of Canadian Municipalities (FCM).

Please be advised that Brantford City Council at its meeting held July 26, 2022 adopted the following:

#### 12.4.9 Potential threat to residential home ownership

WHEREAS concerns from Brantford homeowners have been voiced regarding single family homes being purchased for purposes other than family residency, which practice is a factor in driving up the price of home values making home ownership out of reach for first time home buyers; and

WHEREAS an article in the Toronto Star, Sunday edition reports a case where a foreign national is being investigated for money laundering by "investing" in houses and housing developments in Vancouver. Financial and law enforcement experts say this problem extends to other Canadian cities, most notably in the GTA; and

WHEREAS the Province of British Columbia created an Expert Committee to investigate money laundering in residential real estate, which made several recommendations to the Provincial government to change the Provincial laws and for the Province to make changes to Federal laws to prevent this type of money laundering from occurring; and

THAT the Council of The Corporation of the City of Brantford respectfully CALLS UPON the Province of Ontario to create a similar Expert Committee as was done in British Columbia, to investigate what regulatory action can be taken to better combat money laundering in the Ontario real estate market; and
- B. THAT the Council of The Corporation of the City of Brantford respectfully CALLS UPON the Province of Ontario to implement whatever legislative changes may be necessary to combat money laundering in the Ontario real estate market; and

- C. THAT the Brantford Police Service BE REQUESTED to establish a tip hotline for suspected money laundering; and
- D. THAT the City Clerk BE DIRECTED to forward a copy of this resolution to the Association of Municipalities of Ontario (AMO), Ontario Big City Mayors (OBCM) and the list of other Ontario Municipalities with a request that those municipalities pass similar resolutions, and
- E. THAT the Clerk BE DIRECTED to forward a copy of this resolution to The Honourable Doug Ford, Premier of the Province of Ontario; the Minister of Municipal Affairs and Housing; MP Larry Brock and MPP Willem Bouma.

Please be advised that Brantford City Council at its meeting held July 26, 2022 adopted the following:

# 12.2.15 Seeking Prosperity and Partnership with Indigenous Nations and a Timely Resolution of Haldimand Tract Land Dispute

WHEREAS, in 1784, Sir Frederick Haldimand issued a proclamation allocating six miles on either side of the Grand River, beginning at Lake Erie and extending to the head of the river, for the benefit of the "Mohawk Nation and such others of the Five Nation Indians as wish to settle in that quarter" (also known as the Haldimand Tract); and

WHEREAS the current reservation of land allocated to the Six Nations of the Grand River (SNGR) represents approximately 5% of the 950,000 acres described within the Haldimand Proclamation; and

WHEREAS, in 1995, the SNGR commenced a lawsuit against the Federal and Provincial Governments seeking compensation for lands not surrendered, an accounting for all profits, property, or other assets belonging to or held by the Crown for the benefit of the SNGR, and an accounting for the management or disposition of those assets; and

WHEREAS, negotiations between the SNGR, the Province of Ontario, and the Government of Canada broke down in 2010 resulting in the SNGR recommencing their litigation against the Crown; and

WHEREAS communities within the Haldimand Tract experience the tensions, uncertainty and frustrations arising from failure of the Crown to address the SNGR's land claims in a timely and equitable manner; and

WHEREAS Brantford supports the fair and final settlement of the Six Nations' 1995 lawsuit against Ontario and Canada and is working to establish a meaningful relationship of peace, friendship, mutual respect and shared prosperity with local First

Nations; and

WHEREAS, since 1974, purchasers of land or a beneficial interest in land in Ontario have been paying a percentage of the purchase price for these interests to the Province of Ontario in the form of a Land Transfer Tax; and

WHEREAS Indigenous communities have not historically benefited from the proceeds of Land Transfer Taxes collected by the Ontario Government on the transfer of land and interests in land in Ontario; and

WHEREAS in 2008, the Province of Ontario authorized the City of Toronto to implement a new Municipal Land Transfer Tax to be collected by the municipality, however, a likewise authority was not extended to any other municipality in Ontario; and

WHEREAS municipalities require new tools to build capacity for advancing the meaningful inclusion of Indigenous Peoples in land use planning matters and promoting a local community approach to economic development and shared prosperity; and

WHEREAS the City of Brantford is experiencing significant growth and desires to explore prosperity sharing initiatives with local Indigenous communities in a manner that promotes and strengthens the economies of this region and the economic self-sufficiency of the Indigenous peoples of this region; and

WHEREAS, during the negotiations leading up to the boundary adjustment between the City of Brantford and the County of Brant, the Six Nations of the Grand River requested that a form of prosperity sharing be considered and implemented prior to the approval of the boundary adjustment by the Minister of Municipal Affairs and Housing; however, at the time, a prosperity sharing initiative was not approved by the province as part of the boundary adjustment; and

WHEREAS the scope of municipal powers are determined by the province and therefore municipalities have limited legislative authority to implement unique arrangements with First Nations such as establishing development fees; levying special taxes; or entering into contractual arrangements in order to share in municipal

growth and prosperity, facilitate Indigenous interests in development projects, or create equity interests in municipal projects;

#### NOW THEREFORE BE IT RESOLVED:

- A. THAT the Council of The Corporation of the City of Brantford respectfully CALLS UPON the Province of Ontario and the Government of Canada to resume negotiations, in good faith, with the Six Nations of the Grand River to settle the legal proceedings filed against both governments on March 7, 1995 by the Six Nations of the Grand River; and
- B. THAT the Council of The Corporation of the City of Brantford respectfully CALLS UPON the Province of Ontario to set aside a percentage of all Land Transfer Tax collected by Ontario to be held for the benefit of and remitted to First Nations situated in the province as one means of reparation for historic injustices; and
- C. THAT in addition to the above the Council of The Corporation of the City of Brantford respectfully CALLS UPON the Province of Ontario to empower municipalities within the Grand River Watershed to participate in prosperity sharing with First Nations by way of the following:
  - i. Amend the Municipal Act, 2001 to allow all municipalities in Ontario who so desire to implement a Lot Levy to be applied to purchases on all new builds in the municipality in addition to the Provincial Land Transfer Tax, and held for and remitted to local First Nations for the benefit of Indigenous Peoples' to freely pursue their economic, social and cultural development; and
  - ii. Amend the Development Charges Act, 1997 to include in the list of eligible services a specific charge to be remitted to First Nations in order to provide capacity funding to those Nations who have an interest in protecting and managing cultural heritage and archaeological resources of interest to Indigenous communities, as well as for infrastructure that benefits First Nations communities; and

- iii. Amend the Planning Act to expand the Community Benefits Charge to include a charge that may be collected for the benefit of and remitted to local First Nations for the preservation and advancement of Indigenous interests; and
- D. THAT the Clerk BE DIRECTED to forward a copy of this resolution to The Honourable Justin Trudeau, Prime Minister of Canada, the Minister of Crown Indigenous Relations of Canada, The Honourable Doug Ford, Premier of the Province of Ontario; the Ontario Minister of Municipal Affairs and Housing; the Ontario Minister of Indigenous Affairs; Chief Mark Hill, Six Nations of the Grand River; Chief Stacey Laforme, Mississaugas of the Credit First Nation; Federation of Canadian Municipalities; Association of Municipalities of Ontario; and
- E. THAT the Clerk BE DIRECTED to forward a copy of this resolution to each municipality that oversees lands within the Haldimand Tract and, further, that those municipalities BE REQUESTED to consider supporting this initiative by the passage of similar resolutions; and
- F. THAT a copy of this resolution BE FORWARDED to The Ontario Home Builders Association, the Brantford Home Builders Association, the Ontario Real Estate Association and the Brantford Real Estate Association; and
- G. THAT those bodies BE REQUESTED to provide commentary on this resolution; and
- H. THAT their responses BE PROVIDED in a staff report to city council at a later date.

### Accelerated High Speed Internet Program (AHSIP) - Update

I am pleased to reach out to you today, following the update that the Minister of Infrastructure, the Honourable Kinga Surma provided August 4, 2022 to municipal heads of council regarding the Accelerated High Speed Internet Program (AHSIP) announcement.

The projects announced under the AHSIP process will be moving forward and your municipality is included in one or more of the project areas. As we work with the successful internet service providers to finalize their project agreements, I want you to be aware of next steps and what to expect over the coming weeks.

I would like to note that the project areas are still being finalized. It is possible that your municipality is removed from the project area, but this is likely the result of another project occurring in your municipality, or there is already access to high-speed internet.

However, there may still be underserved homes and businesses. The Ministry is using the best possible data to determine where are the remaining areas of underservice, and is also analyzing all technologies and business models to determine how best to reach these areas and meet the government's 2025 commitment.

#### Support tools

You may recall from previous discussions and town halls that Infrastructure Ontario is leading parts of the AHSIP process. To support your municipality and other stakeholders, they have established a Technical Assistance Team (TAT). This team is now in place and available to provide technical and

administrative assistance to help municipalities carry out their role in supporting these projects, including permitting approvals to meet timelines under the Building Broadband Faster Act (BBFA).

As part of implementation, Infrastructure Ontario is also developing an online tool called Broadband One Window (BOW). The BOW will enable internet service providers, municipalities, and other stakeholders to work collaboratively to review and approve permitting applications, share data and information and provide progress updates on project milestones. The BOW is required for all AHSIP projects and will enhance communication and collaboration amongst all organizations involved. Once onboarded to the BOW, municipalities can also use the platform to request assistance, including from the TAT.

It is important to note that internet service providers may already be in touch with municipal officials for government-funded broadband projects. This is the case because, prior to the completion of the AHSIP process, we already committed to over 190 unique broadband projects under other initiatives, including Improving Connectivity for Ontario (ICON), the Universal Broadband Fund (UBF), and Southwest Ontario Integrated Fibre Technology (SWIFT) initiative.

These are also designated broadband projects per the BBFA. However, they are not required to use BOW. For such projects, the same timeframes outlined in the BBFA apply, but municipalities can use their current permitting processes to issue approvals for projects.

#### **Next Steps**

In terms of what you can expect in the coming weeks, Infrastructure Ontario will be reaching out to your offices to share additional information on AHSIP, BOW, TAT, and a technical onboarding package. They will also be sending out a readiness questionnaire to gather more information about your municipality to ensure the government is ready to provide the right level of support, particularly through the BOW platform.

Infrastructure Ontario will also work with your appropriate staff to schedule onboarding and BOW training sessions this summer.

Once municipalities are set up on the BOW platform, they will be able to use the platform to:

- Receive and respond to permit applications for municipal rights-of-way;
- Share relevant infrastructure data to support designated broadband projects (IO may also be requesting relevant infrastructure data related to designated broadband projects), and
- Monitor the status of AHSIP project(s) in their area, and other designated broadband projects that are using the BOW platform.

As mentioned above, the TAT has been established to assist municipalities and other stakeholders to support activated related to AHSIP. They will provide technical and administrative assistance to municipalities regarding:

- Support around rights-of-way permit application process and issues, approvals coordination and data sharing requests;
- Early informal facilitation and coordination on disputes that may arise between broadband proponents and municipalities on rights-of-way permit applications;
- Provide resources on related legislation, regulation and guidelines; and
- · Support navigation on the BOW platform.

#### **Broadband Guideline**

The Ministry of Infrastructure and Infrastructure Ontario has also updated the Building Broadband Faster in Ontario Guideline (Version 2.0). This Guideline was first released in 2021 with input from municipalities, ministries, and other partners to expedite the delivery of designated high-speed internet projects. Since that time, the government passed the Getting Ontario Connected Act, 2022 which further reduces barriers, duplication and delays, including setting new timelines for municipalities to respond to municipal rights-of-way permits, municipal consent requests, and data sharing requirements to support the deployment of designated broadband projects.

The attached updated version 2.0 reflects this new legislation and recent regulations are now in place. Together, these requirements and tools will help deliver provincially designated broadband projects faster by streamlining processes and removing barriers that may result in additional costs and delays.

Municipalities are required by legislation to have an Integrity Commissioner ("IC") and adopt a Code of Conduct ("Code"). Your municipality has appointed Expertise for Municipalities Non-Profit Association ("E-m") as their IC. The Municipal Act outlines our role as IC E4m serves your municipality as an independent resource, coach and guide. We are focused on enhancing your municipality's ethical culture. We do this by:


Responding to questions from the public about the Code & the Municipal Conflict of Interest Act I"MCIA"). Responding to questions from Council about their obligations under the Code & MCIA. Giving recommendations and/or advice to Council on policy related to ethical behavior of members Providing education/training for Council, Lecal Boards and Public on Code, MCIA, bylaws, policies and legislation governing ethical behavior

Conducting impartial inquiries in response to allegations that a member has not followed the Code or MCIA.

The IC is a statutory officer of the Municipality who reports to Council. Often an IC provides an annual report to Council to provide an overview of the IC's activities during the year. Our report has been created to provide a brief overview of work carried out by E4m as IC for the period of January 1, 2021 to December 31, 2021. This report that shows you, at a glance, what activities we have undertaken for your municipality. We also show you how your municipality compares to the overall total of each activity for ALL of the municipalities for whom E4m provides Integrity Services.



#### **Highlights & Trends**

#### Inquiries:

- In 2021 many municipalities had no costs associated with our Integrity Commissioner Service many because there were no requests for information, addice or concerns raised
- Two (2) requests for inquiry by members of the public were related to the behaviour of municipal Officers or Employees which are not within the
  jurisdiction of the IC to consider and were referred to the municipality.

#### **Matters in Court**

In the case that a contravention of the WCIA has occurred the legislation encourages the IC to make an application to court. Only a judge can determine the behalty for a contravention.

#### In 2021 there were seven (7) matters in court:

. Two (2) were related to the same member of Council

#### Of the matters in court:

- Three (3) were heard by the Judge and in two (2) cases the member of Council was found to have contravened the MCIA one (1) the decision has not yet been made by the Judge the matter was heard in August 2021
- In one case, the judge vacated the Councillor's seat and in the other the judge issued a reprimand.
- One (1) matter we withdrew because the member of Council agreed to resign from Council and not run for election in 2022.
- Three [3] matters were before the court out not resolved by the end of 2021.

#### We want you to know:

- IC inquiries are costly, and members of Council. Committees and Local Boards are encouraged to seek advice from the IC when they are uncertain of their role, of whether to become involved in a matter and for if they may have a disqualifying interest in a matter before Council.
- In 2021 several the requests for inquiry we received were related to members of Council treating imminishal officers /employees and/or other members of Council with considerable disrespect which included disparaging comments about the individual
- Also in 2021, we saw an increase in negative social media directed at Council as a body, some members of Council and municipal officers /employees
  (including the IC), complaints to the Office of the Ombudsman when an individual (complaint or respondent) is not satisfied with the IC's decision as
  Well as complaints to the Office of the Information Privacy Commissioner when either complainants or respondents are not given access to confidential
  information related to IC inquiries. These types of complaints also add significantly to the costs of IC inquiries.

#### A Reminder from your Integrity Commissioner

The 2022 municipal election season is just around the corner! This election year, nomination day is August 19, and voting day is October 24. As we approach nomination day, we want to remind those who may be seeking re-election of some best practices. Your community's Code of Conduct may contain policies that dictate a sitting Councillor's behavior during an electoral campaign, and we encourage you to look for that information. Of course, any information in your Code of Conduct will take priority over the information we've included below.

Firstly, it is important that you, a current member of Council, understand the differences between your obligations as an elected official and as a candidate. It is also important that you do your utmost to differentiate your actions as an elected official and as a candidate.

As you likely already know, one may not use municipal resources, information, or any other municipal property in an election campaign. Here are some examples that we recommend you use to differentiate your activities in each role:

- Not using municipal-issued phones, laptop computers or other devices to conduct campaign activities.
- Not using your public title, your municipal phone number, your municipal email address, or any other information that identifies you as a current member of Council in any campaign-related activity (e.g., social media posts, flyers, mail, business cards, etc.,). Additionally, not using photos or other media that is connected to your activities as an elected official.
- Not using constituent contact information that was obtained through Council business (e.g., they contacted you regarding a by-law via email) for campaign-related activities.

As your Integrity Commissioner, we would like to remind you that inquiries under the Code of Conduct may not be filed or investigated during the period between nomination day and election day. It goes without saying that the broad ethical parameters pertaining to integrity, justice and courtesy, the accurate dissemination of Council decisions, discrimination and harassment and respectful dealings with members of the public (including other candidates) will still apply.

We implore any Councillor seeking re-election to behave in good faith, and due caution in keeping your roles as elected official and candidate separate. If you find yourself with questions during your campaign, please reach out to us at 10:00:E4m solutions.
