Municipal Elections Act, 1996 (s.32) as amended

## NOTICE is hereby given to the Municipal Electors of the THE UNITED TOWNSHIPS OF HEAD, CLARA & MARIA Nominations for the offices of: Mayor (1) and Councillors (4)

Nominations for these offices may be made by completing and filing in the office of the Clerk, nominations on the prescribed form and accompanied by the prescribed nomination filing fee of \$200.00 for the Head of Council and \$100 for all other offices. The filing fee is payable by cash, certified cheque, money order or electronic payment (Debit or Credit).

A nomination must be signed by the candidate and may be filed in person or by an agent during regular business hours between May 2, 2022, and August 18, 2022, and between 9 a.m. and 2 p.m. on Friday, August 19, 2022 (Nomination Day).

In the event there are an insufficient number of certified candidates to fill all positions available, nominations will be reopened for the vacant positions only on Wednesday, August 24, 2022, between the hours of 9 a.m. and 2 p.m. and such additional nominations, if required, may be filed in the office of the Clerk.

Electors are hereby given notice that if a greater number of candidates are certified than are required to fill the said offices, voting places will be opened on the dates stated below for the purpose of voting.

ADVANCE VOTE - Saturday, October 1, 2022 from 11:00 a.m. to 5:00 p.m.

**VOTING DAY - Monday, October 24, 2022 from 10:00 a.m. to 8:00 p.m.** 

## **NOTICE TO THIRD PARTY ADVERTISERS**

Municipal Elections Act, 1996 (s.88.3-88.7) as amended

Under the Act, a registered third-party advertiser is an individual, corporation or trade union that has registered with the Clerk. Third party advertising is separate from any candidate's campaign, and must be done independently from a candidate. Any advertisements or materials that are made and distributed by a candidate, or under a candidate's direction, are part of the candidates' campaign.

Any advertisements that incur an expense which includes broadcasts, print, electronic, or other medium and has a purpose of promoting, supporting or opposing a municipal candidate (Member of Council or School Board Trustee) requires a Third-Party Advertiser to be registered.

Third Party Advertiser(s) must be formally registered by filing a Notice of Registration – Third Party – Form 7 with the Clerk between May 2, 2022 and October 21, 2022 and there is no fee.

Registration permits a Third-Party Advertiser to promote or oppose any candidate.

Third party advertisers cannot accept contributions and/or spend funds until they are registered with the Clerk.
